SUBJECT: Attestation of the FY 2015 DoD Detailed Accounting Report for the Funds
Obligated for National Drug Control Program Activities

We plan to begin the subject review in November 2015. We will perform this review to meet the annual reporting requirements of the "Office of National Drug Control Policy Reauthorization Act of 1998," Public Law 105-277, Title VII, October 21, 1998. The objective of the review is to attest to whether the funds that DoD obligated for the National Drug Control Program in FY 2015 are reported, in all material respects, in conformity with the "ONDCP Circular: Accounting of Drug Control Funding and Performance Summary," January 18, 2013. We will perform the review in compliance with generally accepted government auditing standards. We will conduct sufficient work to express a conclusion and provide negative assurance regarding the presentation of the funds obligated by DoD on the National Drug Control Program for FY 2015. To provide a negative assurance, the procedures we perform will be generally limited to inquiries and analytical procedures. We will consider suggestions from management on additional or revised objectives.

We will perform the review at the Office of the Deputy Assistant Secretary of Defense (Counternarcotics and Global Threats) and DoD Components involved in the National Drug Control Program. We may identify additional locations during the review.
