Communications, Inc. Contracts Awarded by the U.S. Army Contracting Command

We plan to begin the subject audit in January 2013. This audit is the second in a series of audits on the Afghanistan National Security Forces radio contracts. Our objective is to determine whether the U.S. Army Contracting Command obtained fair and reasonable prices for communications equipment and components procured from Datron World Communications, Inc. for the Afghan National Security Forces. We will consider suggestions from management on additional or revised objectives.

We will perform the audit at the U.S. Army Contracting Command, the Defense Contract Management Agency, and Datron World Communications, Inc. We may identify additional locations during the audit.
