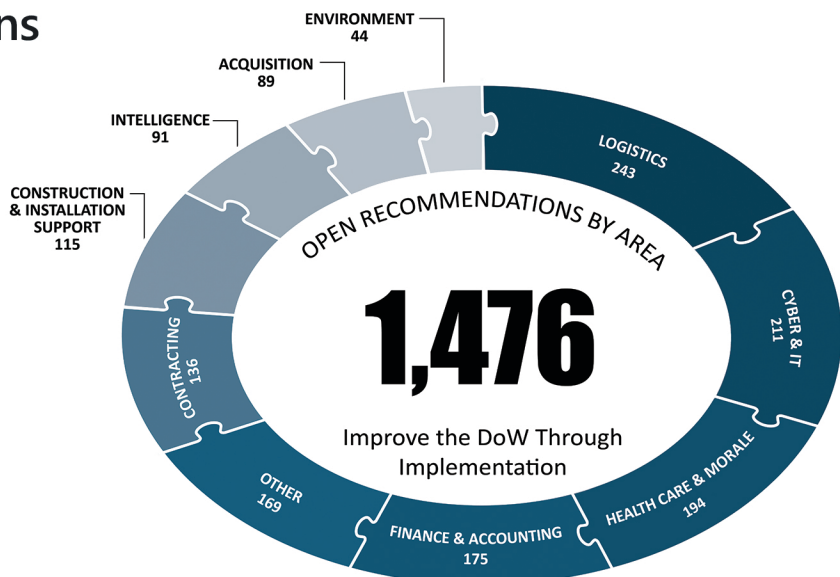

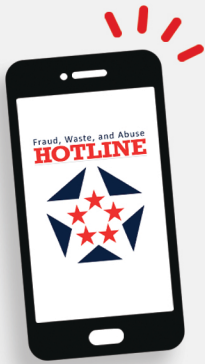

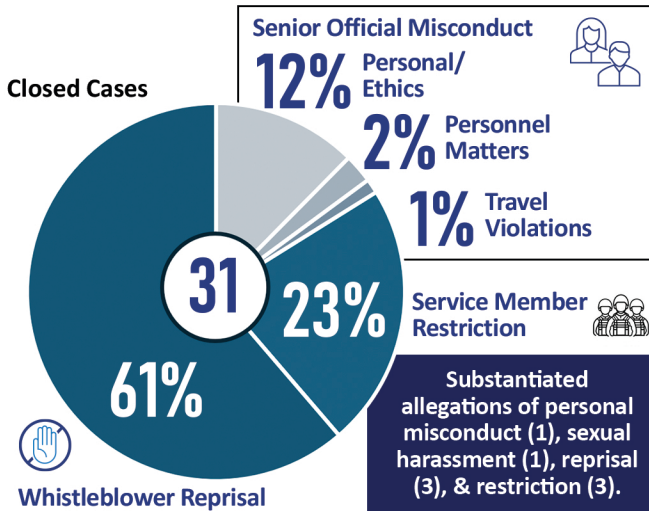

Program Information



- ✓ Program for contractors to self-report violations of law or civil false claims
- ✓ Certain contractors must report wrongdoing up to 3 years after final contract payment

Overseas Contingency Operations

Leads whole of government oversight for nearly \$12 billion budgeted for overseas contingency operations when designated as the Lead IG or Special IG.

Produces quarterly reports that provide a comprehensive account of the operation, including the associated funding. Issues annual oversight plans for each operation.

- Operation Inherent Resolve — maintain the enduring defeat of ISIS in Iraq and Syria
- Operation Enduring Sentinel — contain terrorist threats from Afghanistan
- Operation Atlantic Resolve — deter Russian aggression against NATO
- Operation Southern Guard — support the Department of Homeland Security in illegal alien holding operations at Guantanamo Bay, Cuba
